
Stated Meeting Dates of the District Ten Lodges

FOR IMMEDIATE RELEASE TO ALL CONSTITUENT LODGES

DIRECTIVE: Concerning Lodge Stated and Special Communications And Other Meetings

To all Lodges,

Currently, all parts of Washington have been moved to Phase 3 of Healthy Washington, Roadmap to Recovery effective March 22, 2021. In-person Lodge meetings are now permissible under the statewide guide lines, provided that all the requirements described herein are strictly followed. ANY LODGE THAT HOLDS A MEETING CONTRARY TO THE REQUIREMENTS SPECIFIED BY THIS DIRECTIVE IS SUBJECT TO DISCIPLINE INCLUDING THE IMMEDIATE ARREST OF ITS CHARTER.

Therefore, pursuant to WMC Section 3.01(K) Const., effective May 1, 2021, all Lodges will resume Stated Communications. My Directive of June 13, 2020 cancelling all Lodge meetings is hereby withdrawn effective April 30, 2021. Lodges will resume in-person meetings as provided in the attached "Requirements for In-Person Communications of Lodges."

All the requirements outlined in the attached "Requirements for In-Person Communications of Lodges" MUST BE STRICTLY FOLLOWED. EVERY LODGE MUST APPOINT A COVID -19 PROGRAM SUPERVISOR TO ENSURE THAT ALL SAFETY PROTOCOLS ARE FOLLOWED AND THAT ALL MASKING AND SOCIAL DISTANCING PRACTICES ARE ENFORCED AND ADHERED TO BY ALL ATTENDEES.

If a Lodge's Executive Committee, after consulting with the Lodge membership, determines that it is not prudent or advisable for the Lodge to hold in-person communications, then the Lodge shall hold its Stated Communications on a virtual platform. That platform must allow members to either join via an electronic device or landline telephone. The virtual Stated Communications will be conducted consistent with the attached "Procedures for Virtual Lodge Communications". Any Lodge deciding to meet virtually shall provide all its members a new written notice that its Stated Communications will be virtual and include instructions on how to join the Communication. This notice shall also be provided to the Deputy of the Grand Master for the Lodge's District. Any prior permission issued to a Lodge allowing it not to hold Stated Communications is hereby withdrawn as of April 30, 2021.

This directive does not modify previous instructions concerning the April Stated Communications. April Lodge Stated Communications will be virtual as directed by my letter dated February 11, 2021.

Please be aware that this continues to be a fluid situation. If a Lodge meets in a region or county that is returned to a Phase 1 status of Healthy Washington, Roadmap to Recovery, then that Lodge will not be allowed to hold in-person Stated or Special Communications and must hold Stated Communications virtually. If the guidelines become more restrictive, I will determine if Lodges can continue to meet in-person.

With the sale of the Bellingham Masonic Hall at 2626 West Maplewood in Bellingham the Board of Directors has put out a call to redeem all the bonds that were sold to finance the construction of the facility. The bonds are non- interest bearing so they will be redeemed for the face value of the bond as long as funds are available.

The bonds are being redeemed in phases. The first redemption phase will be to pay the various Masonic groups who are owners of bonds. The process and procedures are nearing finalization and once completed payment will be made.

The next phase will be to process bonds that were purchased by individuals. The board has started the process of verifying contact information for individuals that we can easily find. There are other owners out there that we have lost contact with over the years. A Mason


A Mason is a man who professes a faith in God. As a man of faith, he uses the tools of morality and ethical truths to serve mankind.


A Mason binds himself to like-minded men in a brotherhood that Transends all religious ethnic, social, cultural, and educational differences.
