Business: As per usual, the bills were enumerated and approved for payment, communications disposed of and a financial report given by the secretary, as our Treasurer was on vacation. WM Monte Thompson summarized the minutes from the Finance Committee meeting held at his residence on September 8th. The short of it is that the lodge is healthy for the next year or two but steps are needed now to ensure a sound financial future. Words of Counsel - SW of Whatcom Lodge

Leaving a Legacy...

Masonry exists for us because of the spirit, passion, ritual work and bonds of Brotherly Love formed by those Brothers who have gone before. These intangible qualities define us and shape our lives in and out of the Lodge. Over the centuries, millions of our Brothers have sought to perpetuate our Fraternity through inspiring us to continue their esoteric work.

But there's a tangible side too. Running an organization that serves a couple dozen meals a year for 20 or so people, sponsors special events, donates to assorted charities, and keeps its members informed requires work, effort, planning...and money. Masonic bodies are not designed to acquire idle cash just to say we have it, nor are they designed to run a deficit. Hey, we're not the Feds. We can't go print more money for every worthwhile project that comes along. Masonry is self-funded by its members.

"Oh great! Now he's gonna hit me up for money!" Well, not exactly. Not while you're ALIVE anyway. When was the last time you looked at your Will? Do you even HAVE a Will? Have you considered leaving a token amount of your final estate to your Lodge? Consider your investments. Many folks own Deferred Annuities. Studies have shown that 4 out of 5 dollars invested in annuities come out as a result of death and NOT for retirement income for the owner. Consider listing your Lodge as a beneficiary, or perhaps a contingent beneficiary, just in case you should pass before spending it all. IRA's are another possible source. It's your money, spend it as needed. But, should you pass away before it's gone you can't take it with you. Once again, consider listing your Lodge as a partial beneficiary or contingent beneficiary. Life insurance is another option. For a few hundred dollars, you can create many thousands of dollars. Also, consider existing policies that you may have. Did you buy some life insurance to pay off the mortgage in case of premature death . . . but the house is paid off and you still have the life insurance? Did you buy some life insurance to protect income for your wife in case you died before retirement . . . but now you're retired and you still have the life insurance? If so, consider the Lodge as a partial beneficiary or contingent beneficiary (assuming your family would not be put in a bind). Even small amounts can be helpful. If you still have a spouse or children who are counting on that money, consider listing the Lodge as a 1% or 2% beneficiary with the rest going to your family.

For those of you with the "problem" of a very large estate that's subject to Federal Estate Tax, consider the use of a Charitable Remainder Trust and remember that the M.E.C. has tax exempt status.

Before proceeding on any of this, make sure you discuss the ramifications with your spouse. Washington is a Community Property State and they will need to "sign off" on most of the above strategies. Discuss it with an attorney, and/or a financial advisor or insurance agent. Verify that it's done right and ask the advisor/agent what will happen in different "what if" scenarios. Each company has their own procedure, so I can't give too much "blanket" advice.

In the Great Quarry above, there's little use for money. Studies have shown that more than 98% of us will someday die ... and there are NO points for being the "richest man in the graveyard."

Resolution to Amend By-Laws - September 15th, 2011

Whereas: The lodge continues to struggle to meet the needed annual income to cover basic annual expenses & we know that expenses will be increasing, and

Whereas: The program of voluntary payment of the annual Grand Lodge Dues is only about 75% successful, placing an uneven burden on those who do comply, and

Whereas: The current economic times are not significantly growing our lodge investment funds, it is apparent that more income is necessary:

I therefore propose that ARTICLE III (Fees and Dues) Section 4 [which currently reads: "The annual dues of each member shall be \$50 payable in advance on the first day of January of each year]...be amended to read:

"The annual lodge fees of each member shall be \$50 in Lodge dues, plus the current year's Grand Lodge dues for each chargeable member, payable in advance on the first day of January of each year".

This Resolution will be up for a vote at the October 20th, 2011 Stated Meeting.
