

July Stated Communication...Thursday, July 20th, 2023

Lodge was opened on the 1st Degree at 6:30 P.M. by VW Terrell Goertz who said that the purpose of this Stated Communication was to conduct the business of the Lodge.

The Tyler was invited to Tile from within.

Visitors: Bro. Peter Herksell of Simi Valley Lodge, Simi Valley, CA, who was introduced and greeted.

Reading of the Minutes: Last meeting's minutes were not read as they were previously approved. The regular Sec'y was absent on Vacation.

Communications: Three Letters from Grand Lodge relating to Suspensions of MM's Dennis Okicich (no term set)... Franklyn Gallup, (for term of 3 years) and Raleigh Stone (for term of 6 months) were read in Lodge. The GL letter on Criminal History Reports and Background Checks for Petitions and Affiliations was also read.

Finance Report: We are doing well with \$31,866.14 in checking at 4:54 pm 7/18/2023. Whatcom 151's Edward Jones Inv. Portfolio was valued at \$920,534 at 2.31 pm on 7/19/2023, in June it was valued at \$893,440.70 and in May at \$874,560.62. Cash portion is now at \$1,126.29.

Donation Jar: meal donations \$215.00.

Bills: W #3443 in amt of \$383.71 to Ken Peck for Dinner-kitchen expenses (6/1 \$162.45 + 6/15/\$21.53 + 7/6 \$199.73 for total of \$383.71) (ck #1623); W #3445 in amt of \$194.83 to JW Bruce Smith for Dinner (ck #1624);

Pre authorized: W# 3442 in amt of \$350.00 to Scottish Rite for Inv #1755 July Rent (ck #1621); W#3444 in amt of \$230.00 to Sec'y John Browne for July records, mileage & Internet exp. reimbursement (ck #1622).

It was moved by WB Frank Myers, 2nd by VW Don Higgerson to pay the bills, the motion was *approved*.

Plural Membership Petition: from WB William "Scott" Walsh. The Investigation Committee of Ted Schuman, John Brown and John Browne met with WB Scott Walsh on Tuesday June 20th. Their report is *Full & Favorable*. Grand Lodge of WA conferred with the Grand Lodge CA and gave Whatcom 151 the OK to proceed via e-mail dated July 5th 2023.

A ballot was taken on the petition with the result being Fair, Clear and Bright.

Petition for affiliation: from Br. Dennis Joe Hayes was read (Br. Hayes previously demitted from 151, date unk). Investigating Committee of VWB Craig (chairman), Br. Bill Kappele and WB Ken Peck was appointed and petition was given to VWB Craig for action.

Masonic Youth: WB Thom gave a report on Masonic youth activities for Rainbow and DeMolay.

Term Elections: WM Terrell announced that Lodge elections would be held at the August Stated Communication.

Masonic Education: WM Terrell read an article on "Who Are We and Where Do We Stand". Points made were what is Masonry, why does it exist and how do we take good men and make them better?

Sickness and Relief: Chaplain Bro Jerry was under the weather (per MW Terrell) and WB Chris Bonner appears to be doing better (per VWB Craig).

Announcements: An opportunity for announcements was provided. The following reminders were given: the Granite Falls outdoor degree on 8/5/23; the Lodge BBQ is on August 12thnoon to 3 pm, RSVP to Penny Schuman; there is a planned celebration of Prince David Lodge's anniversary, see poster in the lobby;

The GL letter on Threat to Lodges dtd 7/20/23 was read and a copy of the provided poster was given to VWB Craig who posted it by the Lodge entrance;

WM Terrell announced that he would be absent for the August Special Communication and VWB Craig will take the East;

DDGM: VWB Craig, wearing his DDGM hat, gave details about the upcoming GL gala for the benefit of the Masonic Youth Scholarship Fund.


