Tyler: The Tyler was invited to Tile the outer door and Tyle from the doorway of the Lodge room.


Minutes: The minutes of the previous meetings were not read, having been previously approved.

Communications: Masonic Service items including Short Talk Bulletin and a Letter from the Grand Master regarding Dues Cards for the up-coming term.

Finance Report: The lodge checking account stands at \$33,826.82 (cash \$1,144.02) as of 1:18 pm today. Our Edward Jones Investment Portfolio was valued at \$852,439.83 at 1:21 pm, down some from \$863,614.62 on 10/19/2023.

Donation Jar: The food donation jar contained \$270.00. Master Counselor Cody Little, of Chuckanut Chapter DeMolay, provided a plate of brownies for lodge dessert, unfortunately he could not stay. The brownies were excellent.

Masonic Education: VW Craig Bruner showed the Walt Disney cartoon Mathmagic Land hosted by Donald Duck. It was very interesting and has subtle associations to Masonic ideas.



Prince David report: WB Ken Peck reported on the recent visitation he WM Terrell Goertz made to our sister Lodge's 100 Anniversary Celebration. Ken noted that the WM of Prince David requested that we consider making a visit for the Trowel Exchange on Tuesday Dec. 12th. Several brothers raised their hands to go.

Lodge was opened on the 3RD Degree at 6:30 P.M. by VW Terrell Goertz who said that the purpose of this Stated Communication was to conduct the regular business of the Lodge.

Minutes: The minutes of the Dec 7th Communication were not read having been previous approved but were on hand for anyone wishing to read them.

Communications: Masonic Service Association Short Talk Bulletin and Emessay Notes.

Donation Jar: meal donations came to \$205.00.

Finance Report: The lodge checking account stands at \$39,615.81 as of 7:30 pm 12/20/23. Our Edward Jones Investment Portfolio was valued at \$935,143.13 at 80 pm of 12/20/23.

Bills: W #3471 in amt of \$126.49 to Bill Kappele for 12/7 Dinner expenses (ck #1650); W #3473 in amt of \$29.22 to Moss Roberts for 12/21/23 dinner expense (ck #1652): W #3472 in amt of \$117.77 to Ken Peck for dinner expense for 12/21/2023 (ck #1651):

Pre authorized: W# 3474 in amt of \$375.00 to Scottish Rite for Inv #1807 January 2024 Rent (ck #1653); W#3470 in amt of \$530.00 to Sec'y John Browne for 6 month stipend, Dec. records, mileage, Internet exp. Reimbursement (ck #1649).

It was moved by John Brown, 2nd by Scott Voss to pay the bills, the motion was *approved*.

Business: Bro. Chris Waters has written to me and requested a Dimit from Whatcom Lodge. His wife Tara is having serious health issues so Bro Chris feels it best to reduce family expenses so he'll focus on the local where he now lives. He is not indebted to the lodge so his request will be honored unless a brother here knows of a lodge indebtedness that the Sec'y and Treasurer not aware of. There being no objection the Dimit was signed by WM VW Terrell Goertz and Sec'y VW John Browne.

WB Gordon White has been having a series of both health and financial difficulties making it very hard for him to make his annual dues. A brother covered his 2023 Dues but Brother White is in a bind again this year. Sec'y Browne advised that he'd had a conversation with WB Gordon and they arrived at a decision that Indigency may be the best status for him at the present. After discussion the membership voted it's approval for WB Gordon White be placed into status as Indigent.

Masonic Education: Sec'y John Browne made an educational presentation to the members enumerating the duties of the Lodge Secretary. Describing the process which takes place between the Grand Secretary and lodge secretaries as the year closes from September through to the End Year Report in January of the new year.


